About the Bean Foundation

History

Norwin Sherwood Bean was born in Manchester, New Hampshire in 1873 and graduated from the Massachusetts Institute of Technology with a degree in electrical engineering. He served as Treasurer and Chief Executive Officer of Manchester Savings Bank and was a prominent business and civic leader. His charitable activities included the Manchester Community Chest, Family Service Society, the Institute of Arts and Science, and the Currier Gallery.

Elizabeth Nichols Bean was born in Amherst, New Hampshire and was a member of the Amherst Congregational Church throughout her life. She was active in many charitable organizations, including the Amherst Visiting Nurse Association and Amherst Historical Society. The Bean Foundation began operations upon her death in 1967.

Governance

The Bean Foundation is governed by two Senior Trustees who serve fifteen-year terms and three Term Trustees appointed for three-year terms. The Board of Trustees makes the final decision on all grant applications. It also oversees the Foundation's investment portfolio, currently managed by Goldman, Sachs & Co.

Report of the Trustees

2011 Grants

The Norwin S. and Elizabeth N. Bean Foundation awards grants to nonprofit organizations and public agencies working in arts and humanities, education, environment, health, human services, and for public benefit in the communities of Manchester and Amherst, New Hampshire. The Foundation received 50 requests totaling \$698,217 and awarded 33 grants totaling \$417,526 in 2011. In addition, two education mini-grants were awarded to Manchester public schools for a total of \$550 through the Foundation's Educational Enhancement Fund. Three grants benefitted Amherst residents, eight benefitted the residents of both communities, and the remaining 22 awards went to nonprofits whose requests supported the residents of Manchester.

Historically, the Bean Foundation has generally funded the largest number of grants each year in the category of human services. In 2009, due to the challenging economy and the range of requests that were submitted, there was a 25 percent increase in human service grants over the previous year. In 2010, there was a 50 percent increase in awards in education, and in 2011 the Foundation awarded twice as many grants in education as in human services. Each year the fewest requests are submitted and, therefore, the fewest grants are awarded, in the category of environment.

Six grants in 2011 supported immigrant and refugee needs. Four were directed at adults and families. The Granite State Organizing Project received support to continue leadership training for residents of Elmwood Gardens apartments on South Elm Street in Manchester, New Hampshire. Catholic Charities was funded to offer four courses designed to help immigrants achieve naturalization status, the New Hampshire Humanities Council was funded to provide four Connections literacy series to help new Americans with English language development and acclimating to their new culture, and the Bhutanese Community of New Hampshire received a grant to support Bhutanese immigrants by providing assistance to make integration easier. Two awards were directed at the needs of immigrant and refugee youth. One supported the after school academic program of Inti Soccer and the other funded the participation of adolescent immigrant girls in the "Girl Power Through Horse Power Project" at Upreach Therapeutic Riding Center in collaboration with Manchester's Office of Youth Services and Manchester Housing Authority.

Bean Trustees supported four capital requests. The Foundation contributed to the Manchester Community Music School's Composing Our Future Capital Campaign and awarded a grant toward completing the capital campaign for CASA of NH, which trains volunteer advocates for abused and neglected children in the state's court system. It funded purchase, installation, and initial orientation costs of a Laerdal Sim-Junior Manikin that will be used for training on treatments related to pediatric trauma for Elliot Hospital staff and community emergency personnel, and it granted an award to Amherst Lions Charities so the

organization could purchase and donate a portable aluminum stage to the Town of Amherst for use at events on Amherst Town Common.

A grant was awarded to the Amherst Middle School in memory of Susan Stitt, a Bean Foundation Trustee who served on and chaired the Amherst School Board and was known as an advocate for education, intelligent use of technology, and intercultural understanding. The award will make it possible for seventh grade students to use iPad technology to explore global issues and become more adept at intercultural learning and communication.

The 2011 Annual Meeting of the Norwin S. and Elizabeth N. Bean Foundation was held at the Majestic Theatre on Cartier Street in Manchester and focused on recent changes in the City's West Side. The departure of Bedford students from West High School and the new immigrant population living on the West Side have brought new strengths, new challenges, and the need for new solutions. A panel made up of Executive Director Tika Acharya of the Bhutanese Community of New Hampshire, Director Sister Jacqueline Verville of the Holy Cross Family Learning Center, Executive Director Rob Dionne of the Majestic Theatre, and Educator Susan Wilkes, Director of Chorus and Orchestra at Manchester High School West, spoke on the changes and the creative responses being taken to address them.
